**ASSESSING PERIOD: JANUARY 4 – MARCH 15, 2021**

All farmers are required to render ALL farm equipment located in Custer County on January 1<sup>st</sup> to the Custer County Assessor for taxation ANNUALLY between January 4<sup>th</sup> and March 15<sup>th</sup>. Failure to do so will result in penalties added to your assessment.

- Personal property rendered March 16<sup>th</sup> – April 15<sup>th</sup> will receive a mandatory 10% penalty.
- Personal property rendered after April 15<sup>th</sup> will receive a mandatory 20% penalty. Per OS68 Sec 2836(d).

**Enclosed is your farm asset list per our current records. All items listed are acquired from your rendering, obtained from chattel mortgages filed or visual inspection discovery.**

**\*\*REMEMBER – YOU ARE REQUIRED TO CONTACT THE ASSESSOR’S OFFICE EVERY YEAR BETWEEN JANUARY 2<sup>nd</sup> AND MARCH 15<sup>th</sup> EVEN IF YOU HAVE NO ASSET CHANGES TO AVOID PENALTIES. CONTACT OUR OFFICE OR ASSESS AT ONE OF THE CONVENIENT LOCATIONS LISTED BELOW. \***

**2021 CUSTER COUNTY ASSESSMENT SCHEDULE**

ALL FARMERS MUST CONTACT THE OFFICE EACH YEAR **BEFORE MARCH 15** TO ASSESS YOUR FARM EQUIPMENT AND TO RENEW AG SALES TAX EXEMPTION CARDS. **FAILURE TO ASSESS WILL RESULT IN PENALTIES.**

If you have purchased a home since 1-1-2020 you need to file a new homestead. Contact the Assessor’s office before 3-15-2021 to apply.
