INSTRUCTIONS FOR SUBMITTING BID PROPOSALS

1. This entire packet (Invitation to Bid, Instructions, Minimum Specifications, Affidavit for Filing with Competitive Bid, Affidavit for Contracts and Payments, and W-9) shall be known as the "Invitation to Bid" form. Fill out the "Invitation to Bid" form *completely*.
2. Identify the outside of the sealed envelope as follows:

All bids will be opened at **9:30 o'clock a.m., March 21, 2016** during the County Commissioner's meeting held in the Custer County Courthouse, Arapaho, Oklahoma, Room 104, at 675 West "B" Street, Arapaho, Oklahoma.
5. All forms must be filled out completely. Any incomplete forms could result in rejection if the Board of County Commissioners considers such action to be in the best interest of Custer County.

CUSTER COUNTY LAW ENFORCEMENT CENTER TRUST**

Custer County Commissioners are soliciting bids for the labor only for the installation of concrete, ditch liners, sheet piling, pipe drain, energy dissipaters, and curb openings with flumes. *Engineer's specifications are available at the Custer County Clerk's Office at the Courthouse for reviewing.* All work to be completed by specifications listed, or with express written changes approved by Commissioners. All materials such as concrete, steel, pipe and fill will be provided by Custer County. All labor and equipment shall be the contractor's responsibility. Contractor shall provide proof of insurance prior to the project commencement.

Please note Option B in specifications. Bid separately all concrete, ditch liner, curb openings and flumes separate from sheet piling.

MINIMUM REQUIREMENTS:

- A. Approximately 470 LF concrete ditch liner, flume and energy dissipater..... \$ _____

Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return.
