Overview:

The system is made up of five areas:

- 1. Main Barn Show area (Zone 1)
- 2. Hog Barn (Zone 2)
- 3. Cattle Barn (Zone 3)
- 4. Poultry Barn (Zone 4)
- 5. Control Room (Zone 5)

ALL AREAS SHALL USE THE RECOMMENDED SPECIFICATIONS LISTED.

ZONE 1 – MAIN BARN – SHOW AREA

The area requires a full range sound system with speakers suspended from overhead. This area will be used for show ring announcement and music play back.

MINIMUM SPEAKER REQUIREMENT:

Eight (8) full range loudspeakers from recommended specifications list.

Speakers to be hung overhead from rated hardware.

Speakers to be pointed in a way that minimizes reflection from walls and ceiling.

Speakers to be powered by one commercial rated 70v power amplifier.

Audio inputs – one XLR audio input to be located in this area.

All audio inputs will be installed in a weather rated housing and conduit.

All inputs from this Zone will be routed via the digital mixer to serve all areas.

ZONE 2 – HOG BARN

This area requires a full range sound system with speakers suspended from overhead. This area will be used primarily for announcements and background music. This area has a high residual noise floor when being used due to fans, clippers, etc.

MINIMUM SPEAKER REQUIREMENT:

Nine (9) full range loudspeakers from recommended specifications list.

Speakers to be hung overhead from rated hardware.

This area will have in-room volume control.

Control must be selected from recommended control specifications.

Ouantities of volume control shall be based on speaker selection.

Volume control must be mounted on wall at 8 ft. AFF in weather rated enclosure.

Weather rated enclosure, conduit and all other necessary hardware to be provided by Installer.

Audio inputs – one XLR audio input to be located in this area.

All audio inputs will be installed in a weather rated housing and conduit.

All conduit and hardware to be provided by Installer.

The XLR audio input in this area will serve only this area.

The signal will be routed in a way via the digital mixer that this microphone input will speak in this room only.

ZONE 5 – MAIN CONTROL ROOM:

This area shall provide the following:

Main Equipment Rack:

A 27-unit glass front with lockable door.

Rack will be located in the main control room and contain wireless microphone receivers, rack shelves for storage, microphones and cable storage, power conditioning and power sequencing system, mixer and amplifiers.

System Mixer:

A 16 channel digital mixer with a minimum of 16 preamp inputs and 6 aux outputs.

Microphones, Stands and Accessories:

The system will include one (1) wired microphone with switch;

one (1) wireless hand-held microphone system (high quality, Frequency A or G3 Band preferred) and one (1) wireless headset microphone system (wireless body pack system, Frequency A or G3 Band preferred)(high quality head worn condenser microphone).

Steel microphone stands, clips and cables will be provided with the system.

Power System:

Each of the first four Zones will have a minimum of one (1) XLR input. These XLR inputs will be wired direct into the digital sound mixer.

The incoming signals from Zone 2, Zone 3 and Zone 4 will be routed back to the speakers in the area it originated only. These Zones are located in different barn areas.

Wires from one barn to the next must be flown overhead on tensioned wire suspension system and maintain a minimum height of 14 feet.

All necessary hardware and machinery needed to suspend wires overhead will be provided by the Installer.

All wires will originate in the Control Room Area.

Total 12 awg speaker wire needed is estimated at approximately 7000 ft.

Total 2 conductor 22 awg shielded wire needed is estimated at approximately 5000 ft.

Total estimated distance of needed suspension system between Zone 1 and Zone 3 is less than 100 ft

Total estimated distance of needed suspension system between Zone 1 and Zone 4 is less than 100 ft.

System Installation Notes:

Sound Contractor will install and test System.

Contractor will provide all tools and machinery necessary to complete the installation of the System. This will include scaffolding, Scissor Lifts, etc.

System functionality will be demonstrated for Custer County.

Contractor must provide up to two (2) one hour training sessions on site that demonstrates system operation.

System and work must be covered by a one (1) year warranty agreement unless otherwise stated in Recommended Specifications.
