APPLICATION FOR CUSTER COUNTY'S SHARE OF THE LOCAL ASSISTANCE AND TRIBAL CONSISTENCY FUND

The American Rescue Plan Act established the Local Assistance and Tribal Consistency Fund by which the U.S. Treasury is authorized to allocate two billion dollars (\$2,000,000,000.00) to eligible revenue sharing counties and eligible Tribal governments across fiscal years 2022 and 2023 for use on any governmental purpose except for a lobbying activity. A total of 2,086 local governments are eligible to receive these payments, and Custer County is among them. According to the allocation table for eligible revenue sharing county governments available online at https://home.treasury.gov/system/files/136/LATCF-Allocations-for-Eligible-Revenue-Sharing-County-Governments.pdf, Custer County is eligible for a fifty thousand dollar (\$50,000.00) allocation in FY23.

To receive payments, eligible revenue sharing county governments must submit their information online through the Treasury Submission Portal, which can be accessed online at https://home.treasury.gov/policy-issues/coronavirus/assistance-for-state-local-and-tribal-governments/local-assistance-and-tribal-consistency-fund. County governments will be required to complete payment information and sign an award agreement. The award agreement will cover both tranches of payment. After an eligible revenue sharing county government's submission is received, Treasury expects that it will take approximately 4-5 business days for Treasury to review and process the payment.

The Board of County Commissioners of Custer County hereby elects to submit its information through the Treasury Submission Portal and to sign the award agreement, which will cover both tranches of payments. The Custer County Treasurer is authorized and directed to proceed to enter the necessary information through the Treasury Submission Portal, to coordinate with the Board as may be necessary to sign the award agreement and to carry out such further acts as may be necessary for Custer County to receive its due allocations from the aforementioned Fund.

Upon receipt of these allocations, they will be deposited into Custer County's Fund 1570.
