**SPECIAL EXECUTION AND ORDER OF SALE IN FORECLOSURE**

GREETINGS:

WHEREAS, in the District Court of Custer County, Oklahoma on June 12, 2018, in the above entitled and numbered cause, the Plaintiff recovered a judgment for the sum of \$78,985.59, with 1.99% interest between January 14, 2017, and February 14, 2017, then 1.20% per annum thereafter until paid; title search and examination expense with interest per annum thereon, until paid; advances for preservation of the subject property with interest per annum thereon, until paid; and a further judgment to Plaintiff and Plaintiff's attorneys for a reasonable attorney's fee, and for all costs of this action, and recovered a further judgment and decree of foreclosure of said mortgage given to secure said debt on the property hereinafter described, for the full amount of the judgment, above set forth, and foreclosing said lien, and ordering that if said judgment be not paid, that a special execution issued from the office of the Court Clerk, directed to the Sheriff of Custer County, commanding said Sheriff to levy upon, and sell said real estate, with appraisal, after notice as provided by law, and

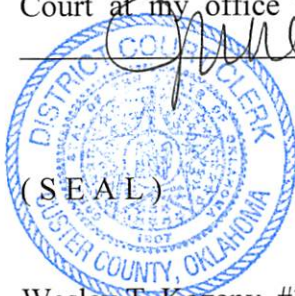
