WHEREAS, on August 17, 2017, in Cause No. CJ-2016-17, wherein Oil Valley Petroleum, LLC was Plaintiff, and Caddo Bay Energy, LLC was Defendant, Plaintiff recovered a judgment against Defendant as follows:
