WHEREAS, On the 18th day of August, 2025, in Case No. CJ-2025-45, the District Court of Custer County, Oklahoma, entered a judgment in favor of Plaintiffs, Erick Marshall and Sarah Marshall (“**Plaintiffs**”), and against Defendants, Sprayfoamsaves, LLC and Frashon Ford (“**Defendants**”) for the sum of \$31,054.72, reasonable attorney’s fees in the sum of \$4,484.50, and for costs of the action in the amount of \$535.38 for a total sum of \$36,074.60; and a further decree of foreclosure of liens upon the following described real property situate in Custer County, Oklahoma:

Lots 13 and 14, Block 2, Kobels Second Addition to the City of Clinton, Custer County, Oklahoma (the “**Subject Property**”),

and directing the same be sold, with appraisalment, and to apply the proceeds arising therefrom as follows:

2. To reimburse Plaintiffs for their reasonable attorney’s fees and costs in the amount of \$5,019.88;
3. To the payment of costs, including court and sheriff’s costs, and the costs of sale of this action and the sale of the Property herein accrued and accruing;

4. To the payment of Plaintiffs for their reasonable attorney's fees and costs incurred for the enforcement of this judgment.

6. The balance to be paid to the Court Clerk of Custer County, to await further order of this Court.
