RESOLUTION NO. 2021-08-23A COVID-19 PROTOCOL FOR CUSTER COUNTY, OKLAHOMA

WHEREAS, due to the continuing threat from Corona Virus (Covid-19 and subsequent Variants), immediate attention is required to protect public health, reduce further damage and ensure public safety; and

WHEREAS, the Elected Officials of Custer County, Oklahoma have established the following Covid-19 Protocols for County Employees:

- 1. MUST PROVIDE TEST RESULTS
- 2. MASKS ARE RECOMMENDED BUT NOT REQUIRED
- 3. FOR VACCINATED:
 - A. No Symptoms Mask up for 14 days
 - B. Any Symptoms Test Immediately
 - C. If Positive Result quarantine for 10 days from test date County will pay
- 4. FOR NON-VACCINATED:
 - A. If Positive Result quarantine for 10 days from test date and no symptoms County will pay. No test required to return to work
 - B. Direct Contact with Positive Covid:
 - Household quarantine for 15 days and test on Day 15 with no symptoms and return on 17th day. With Symptoms – test immediately – positive result – quarantine for 10 days from test date.
 - 2. Non-Household quarantine with no symptoms can test on Day 5 and return on Day 7 with a negative test. If showing symptoms test immediately. If positive quarantine 10 days.
- 5. If Employee chooses not to test after 5 days, then quarantine is 14 days. County will only cover 5 days.
- 6. FOR THE PURPOSES OF THIS RESOLUTION, QUARANTINE MUST BE MAINTAINED WITH NO EXPOSURE TO THE PUBLIC. FAILURE TO FOLLOW THESE PROTOCOLS WILL RESULT IN THE USAGE OF THE EMPLOYEE'S PERSONAL TIME.

WHEREAS, the situation for Corona Virus is ever changing. The Board of County Commissioners of Custer County, Oklahoma shall address any required changes in the Protocol in thirty days of adoption of this Resolution, or sooner as needed.
