Change Order Request

Per your request to add an overhead door to the end of the corridor includes the following.

- Material and labor to frame in existing hole in corridor to accommodate a new overhead door, and frame new hallway in office.
- Material and labor to case opening with colored sheet metal.
- Material and labor to install a 10'-0 wide x 10'-0 tall double steel insulated overhead door.
- Material and labor to sheet interior walls of corridor with colored metal R-panel.
- Material and labor to install (3) LED lights on ceiling of corridor area.
- Material and labor to demo and frame a new opening in the office exterior wall for new walk door.
- Material and labor to install new hollow metal door and frame in new opening in
 office wall. This new door is required by code, for emergency egress, for closing off
 corridor exit with the overhead door.
- Material and labor to install level 1 granite in lieu of Plastic laminate at bathroom and kitchen counter tops.
- Proposed work will add 21 days to contract time.
