

RESOLUTION NO. 2026-08-31B
DECLARING A BURN BAN
FOR CUSTER COUNTY

WHEREAS: The Custer County Board of County Commissioners pursuant to the authority granted to the Board by Section 16-26B of Title 2 of the Oklahoma Statutes, does hereby proclaim that extreme fire danger exists in Custer County. This situation (as defined in Section 16-26 B 1 a-d, Title 2, O.S.) has been verified by a documented concurrence of the majority of the County's municipal and rural fire chiefs, or their designees.

WHEREAS: By virtue of this resolution, it is unlawful for any person to set fire to any forest, grass, range, crop or other wild lands, or to build a campfire or bonfire, or to burn rubbish or other material that may cause a forest, grass, range, crop, or other wild land fire. All outdoor burning in progress at the time of the passage of this resolution are ordered to be fully extinguished immediately by the property owner or his/her designate. Controlled burns or other activities stated herein which have occurred prior to the passage of this resolution and are ongoing at the time of this resolution shall not be a defense for violation of this resolution.

WHEREAS: Any law enforcement officer of the State of Oklahoma may carry out the enforcement of this resolution. Any person convicted of violating this resolution shall be guilty of a misdemeanor and shall be subject to a fine of not more than Five Hundred Dollars (\$500.00), to imprisonment for not more than one (1) year, or to both such fine and imprisonment.

WHEREAS: Certain exceptions may be attached to this resolution by Custer County.

EXCEPTIONS: Exceptions may be authorized as checked below:

 NO EXCEPTIONS ARE GRANTED TO THIS BURN BAN.

 X **FOR EQUIPMENT RELATED TO ROAD CONSTRUCTION PROJECTS**
Equipment which uses propane or other controlled-type burners is generally regarded as safe, however it will be required to have a water pumper on standby any time this equipment is used near a grassy right-of-way. Such requirement is the responsibility of the company or organization conducting the construction, and is not the responsibility of the fire department within the jurisdiction in which the construction activities are taking place.

 X **WELDING/CUTTING TORCH/GRINDING ACTIVITIES**

1. When conducted over a non-combustible surface of at least 10 feet by 10 feet and when welding blankets or screens are used to cover combustible vegetation; and
2. Wind speeds must be less than 20mph: and
3. A fire watch, other than the welder, is posted at the welding/cutting torch site with pressurized water or fire extinguisher.

CAMPERS AND OUTDOOR COOKING

Outdoor campfires or bonfires are prohibited. LPG, natural gas grills and charcoal-fired cooking outside in a grilling receptacle are permitted provided that the activity is conducted over a non-flammable surface and at least five feet from flammable vegetation.

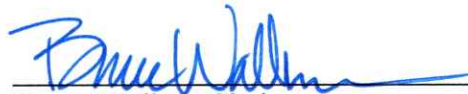
PUBLIC FIREWORK DISPLAY

An exemption for public firework displays has been approved with prior approval of local fire departments and the State Fire Marshall. Firework displays will be permitted only by licensed firework professionals in designated areas. No individual use of fireworks will be permitted during the duration of this burn ban.

NOW THEREFORE BE IT RESOLVED: This Resolution shall be effective immediately for a period not to exceed fourteen (14) days from the date of passage effective 12:00 a.m. as approved by the Board of County Commissioners. If extreme fire danger conditions persist, subsequent resolutions may be passed. This burn ban may be removed at any time during the fourteen (14) day period by the same method by which it was approved, and may be overridden at any time by a lawfully declared Burn Ban by the Governor of the State of Oklahoma.
